Its Fee Structure  
For Expatriate  
Quota Facilities**



## The Federal Ministry of Interior (FMI) has been undergoing some internal restructuring.

On the 22nd of January 2022, the FMI updated its guidelines on the administration of Expatriate Quota and other business instruments in Nigeria. A copy of our newsletter on this is available on our website [here](#).

It is in furtherance to this that the FMI has released its revised fee structure for all Expatriate Quota facilities as highlighted below:
